## PRODUCT DESCRIPTION

JTAPE Green Fine Line Masking Tape uses a thermally stabilised PVC backing with a rubber-based pressure sensitive adhesive. It is highly flexible, easy to curve and will hold and cleanly remove from surfaces in temperatures up to 150°C/300°F for at least 1 hour. After demasking, it will leave no residue and a sharp, clean separation line.
